Let us Save this Whistle Blower whose Life is at Risk for Exposing the Corruption of ACP

The whistle blower, Shri. Mukesh Thakur & Lucky Gupta has brought rampant corruption of PayTM to the notice of Ludhiana Police, which was never taken cognizance of. In spite there are three FIR registered by Ludhiana Police against the whistle blower, on the instance of ACP Shri. Sachin Gupta. The whistle blower were not intimidated of the charges nor there relatives were informed about their arrest and were put to third degree torture in SP, CIA office, clearly violating the provision of law.

Police brutality of Shri. Sachin Gupta, Asst. Commissioner of Police, Ludhiana at Punjab is a civil rights violation that occurred when he used excessive force against Shri. Mukesh Thakur & Lucky Gupta, the whistle blower which was more than necessary. Excessive force by a law enforcement officer is a violation of a person's rights. He further violated human rights, by making arbitrary arrest and detention, torture and abuse use of their official power.

A series of Supreme Court judgments have laid down the ratio of holding the state liable for police misconduct, abuse of power and, making pecuniary compensation a significant remedy for such violation of fundamental rights. The legal position as it stands now is clear that a violation of fundamental rights due to police misconduct, can give rise to a liability under public law, apart from criminal and law of torts.

It is clear to police that if they resort to unnecessary and excessive use of force, and abuse use of power, they will have to face consequences. This is the minimum requirement of a civilized society which claims to be the biggest democracy.
